Please note the following:

- We assess financial assistance on an individual basis, using Statistic Canada's Low - Income Cut-offs (LICO) guidelines.
- 100% of your child's fee might not be covered by the fund – assistance will depend on the level of need. Please be prepared to pay a percentage or the whole amount.
- To determine eligibility we look at your total household income (combined income of all adults in your household).
- Please tell us of any special circumstances that may affect your ability to afford your child/ren's enrolment in Scouting (information will be kept confidential).
- Only children under 18 years are eligible for funding. Rovers (18-26yrs) are only eligible if they are contributing to their group in a productive way.
- Please fill in **one application form per youth.**
- This form must be completed by the youth's parent or guardian only.
- The application will be reviewed and you will receive a letter in the mail, informing you of the amount of your child's fee that will be covered by financial assistance and the portion (if any) left to pay. The Group Commissioner will also be informed of any remaining amount due.
