- Only children attending Chinook Council Summer Camp program are eligible for funding.
- Please fill in one application form per youth.
- This form must be completed by the youth's parent or guardian only.
- The application will be reviewed and you will receive a letter in the mail, informing you of the amount of your child's fee that will be covered and the portion (if any) left to pay.
